Initiated a major fund-raising initiative for the 2020 purchase of 2 parcels of land in Dummerston, VT when all funds have been raised. Raised a total of \$60,000 in private donations and a grant award of \$116,000 from the Vermont Housing and Conservation Board, payable upon acquisition in 2020 . As part of this project, we procured donated permanent Trail Easements from 4 Dummerston families and a donated Trail License from a fifth.

Stewardship of 705 acres of forest land and trails open to the public for outdoor recreation. Built a new hiking trail across the parcels purchased in 2018 facilitating access from Brookline, VT. Controlled invasive Buckthorn on the summit through our Sheep Grazing Project and used a heavy duty grinder to remove a buckthorn infestation along one of our summit access trails. Stewardship includes payment of all related property taxes and insurance.
