1 Briefly describe the organization's mission: Putney Mountain Association believes there is a vital link between humans and the natural environment. Our primary objectives are to strengthen that link by preserving undeveloped land in southeastern Vermont for the benefit and enjoyment of present and future generations and to protect the natural habitat and wildlife corridor of the area.

4a (Code:) (Expenses \$ 6,525 including grants of \$) (Revenue \$) Acquisition - Initiated a major fundraising campaign to acquire a 159-acre parcel (Fall Brook). Completed an appraisal to determine fair market value of the property. Purchase will be completed in 2025.

4b (Code:) (Expenses \$ 13,474 including grants of \$) (Revenue \$) Stewardship - Stewardship of 926 acres* of forestland and wetlands. An ecological assessment of a 99-acre parcel was completed including natural community mapping, invasive plant inventory, and rare plant species documentation. The boundaries of a recently donated 26-acre parcel were identified and marked. Incorporated a new conservation software program including training. Fourteen fee-owned parcels were mapped to the conservation software. * Stewardship includes payment of all related property taxes and insurance.

4c (Code:) (Expenses \$ 40,608 including grants of \$) (Revenue \$) Trails - PMA re-routed the summit trail bypassing wetlands to protect sensitive wildlife. Crushed stone was set, stone turnpikes built and culverts installed. 16 volunteers recorded 223 hours of assisting in this notable improvement of the summit trail (one of the most heavily trafficked footpath in VT). A granite bench was installed along the summit trail to commemorate two long-term board member's vision, service and dedication to PMA's mission. Purchased, assembled and installed a new solar powered water pump in a surface well to provide water for sheep that graze on invasive glossy buckthorn on the Putney Mountain Summit Clearing. Also purchased additional fencing to keep the sheep secure.

Form 990, Part I, Line 1: The Putney Mountain Association believes there is a vital link between human beings and the natural environment. Our primary objectives are to strengthen that link by preserving undeveloped land on Windmill Ridge in southeastern Vermont for the benefit and enjoyment of present and future generations and to protect the natural habitat and wildlife corridor of the area.

Form 990, Part I, Line 6: Seventy plus volunteers and hundreds of hours were involved in the community engagement, stewardship and trails and grazing programs. The Community Engagement Committee participated in locally sponsored events, a choir concert and Harvest Festival. 6 volunteers spent 25 hours preparing for the events, manning a table to promote PMA's mission, membership, donations, trails systems and recruitment of board members. Putney Mountain Summit continues to serve as the site of Vermont's longest running Hawkwatch. 2024 tallied a total of 19,428 raptors migrating over the ridge including an all-time season high of 16,206 broad-winged hawks. After 40 years of working to connect the Windmill Ridgeline trail from Grafton to Prospect Hill in Dummerston, the opening of final trail segment (Hague Road to Holland Hill Road) of the Missing Link was celebrated. 27 community members showed for the opening celebration and 22 participants hiked the trail together. Volunteer trail blazers, Board Trustees, and members spent over 20 hours publicizing, organizing, explaining the trail creation, educating the public about Vermont's largest Ash Tree, and driving hikers back to their cars. The Stewardship Committee monitored eight vernal pools and mapped one new pool to Vermont's Vernal Pool Atlas. Breeding bird surveys were conducted at 13 sites with documentation of several Vermont Species of Greatest Conservation Need. Invasive plants were monitored and controlled as feasible. Two parcels were monitored and controlled as feasible. Two parcels were monitored for hemlock woolly adelgid.
